The Correspondent, E.R.K Educational Trust, Dharmapuri District has requested the Government to grant permission to start four years B.Pharm course in the name and style as “E.R.K. College of Pharmacy” at Erumiyampatti Village, Kokkarapatti Post, Pappireddipatti Taluk, Dharmapuri District from the academic year 2021-2022.

2. In Government letter fourth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed pharmacy college has fulfilled the conditions prescribed by the Government in the Government Orders first to third read above and as per the norms of the Pharmacy Council of India, New Delhi.

3. In his letter fifth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Pharmacy Council of India, New Delhi and recommended to grant permission to the Correspondent, E.R.K Educational Trust, Dharmapuri District to start four years B.Pharm course in the name and style as "E.R.K. College of Pharmacy" at Erumiyampatti Village, Kokkarapatti Post, Pappireddipatti Taluk, Dharmapuri District from the academic year 2021-2022.

4. The Government examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Correspondent, E.R.K Educational Trust, Dharmapuri District to start four years B.Pharm course with an annual intake of 60 (sixty) students in the name and style as "E.R.K. College of Pharmacy" in S.F. Nos. 37/5D3, 37/6A and 78/4 Erumiyampatti Village, Kokkarapatti Post, Pappireddipatti Taluk, Dharmapuri District – 636 905 from the academic year 2021-2022, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.148, Health and Family Welfare (PME) Department, dated: 24.04.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building completion certificate from the competent authority. i.e. PWD Engineer.
- ii. The Trust should obtain Clearance Certificate from the Tamil Nadu Pollution Control Board, Dharmapuri District.
- iii. The Trust should obtain the recognition / affiliation from the Pharmacy Council of India, New Delhi and the Tamil Nadu Dr. M.G.R. Medical University respectively.

2. In its Government letter fourth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Pharmacy has fulfilled the conditions prescribed by the Government in the Government Orders first to third read above and the Pharmacy Council of India, New Delhi.

3. In his letter fifth read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Pharmacy Council of India. Hence, the Director of Medical Education has recommended to give permission to the Correspondent, E.R.K. Educational Trust, Dharmapuri District to start two years D.Pharm course in the name and style as "E.R.K. College of Pharmacy, Dharmapuri District" with an annual intake of 60 students from the academic year 2019-2020.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Correspondent, E.R.K. Educational Trust, Dharmapuri District to start 2 years D.Pharm course with an annual intake of 60 (sixty) students in the name and style as E.R.K. College of Pharmacy in S.F.No.37/5D3, 37/6A, 45/12B, 46/2,46/1C1, 46/4B2, 78/4, Erumaiyampatti Village, Kokkarapatti (Po), Pappireddipatti (Tk), Dharmapuri District from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Correspondent, E.R.K. Educational Trust, Dharmapuri District is permitted to start 2 years D.Pharm course with an annual intake of 60 (sixty) students in the name and style as E.R.K. College of Pharmacy in S.F.No.37/5D3, 37/6A, 45/12B, 46/2,46/1C1, 46/4B2, 78/4, Erumaiyampatti Village, Kokkarapatti (Po), Pappireddipatti (Tk), Dharmapuri District from the academic year 2019-2020, subject to the following conditions:-

- a) The Trust should construct 25 sq.mts Aseptic room before admitting the students.
- b) The Trust should obtain the building completion certificate from the competent authority for the proposed Pharmacy College and submit to the Government before admitting the students.
- c) Admission of students shall be made as per the rules fixed by the Government from time to time;
- d) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Pharmacy Colleges;
- e) The Trust should obtain recognition from the Pharmacy Council of India before admitting the students;

- f) The Government have the right to utilize the Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc;
- g) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on re-inspection of the centres.

5. The Director of Medical Education is directed to take necessary further action accordingly.
