### PREAMBLE :

In the reference 1<sup>st</sup> cited, E.R.K. Educational Trust, rumiyampatti Village, Kokkarapatti Post, Pappireddipatti Taluk, Dharmapuri District has obtained Government Order from Health and Family Welfare Department, Secretariat, Chennai, Tamil Nadu to conduct B.Pharm Degree Course in the name and style of **E.R.K. College of Pharmacy**, in S.F. Nos. 37/5D3, 37/6A and 78/4, Erumiyampatti Village, Kokkarapatti Post, Pappireddipatti Taluk, Dharmapuri District – 636 905 with an annual intake of 60 seats for the academic year 2021-2022.

2. In the reference 2<sup>nd</sup> cited, the University has granted the Provisional Affiliation order to E.R.K. College of Pharmacy, Dharmapuri Dist., for conducting the **B.Pharm.** Degree Course with an annual intake of **60 seats** from the Academic Year 2021-2022.

3. In the reference 3<sup>rd</sup> the University has granted permission for the increase of intake from 60 to 100 seats in B.Pharmacy Degree Course from the academic year 2023-2024 to conduct B.Pharmacy degree course at E.R.K. College of Pharmacy, Dharmapuri District.

4. In the reference 4<sup>th</sup> cited, the University has granted Continuance of Provisional Affiliation to the said Institution for conducting B.Pharm. Degree Course with an annual intake of 60 seats for the Academic year 2023-2024.

5. In the reference 5<sup>th</sup> cited, the Pharmacy Council of India, New Delhi (PCI) has granted approval for the academic year 2024-2025 to conduct B.Pharmacy degree course at E.R.K. College of Pharmacy, Dharmapuri District.

6. An Inspection Commission was appointed to verify the infrastructural and other facilities available at E.R.K. College of Pharmacy, Dharmapuri District for the academic year 2024-2025. Consequently, the requisite inspection was conducted on 12.05.2023 to verify the infrastructural, teaching and other facilities available at the said institution.

7. On scrutiny of the inspection report and the documents submitted by the said institution, no specific adverse remarks or objection was found.

**ORDER:**

In pursuance to the Resolution No.11 passed by the 306<sup>th</sup> Governing Council Meeting held on 08.05.2025, inspection report submitted by the inspection commission, approval of Pharmacy Council of India for the academic year 2024-2025, the University grants Continuance of Provisional Affiliation to E.R.K. College of Pharmacy, Dharmapuri District for conducting B.Pharm. Degree Course for the academic year 2024-2025, as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University.

12. The approval from relevant Council should be produced every year to consider further Continuance of Provisional Affiliation.

13. Any other condition which the University considers necessary to impose from time to time should be followed strictly.
